INSURANCE REQUIREMENTS

Bid # 13118

Insurance: The Contractor must obtain, for the Contract term and any extension of it, insurance issued by a company or companies qualified to do business in the State of Illinois and provide the County with evidence of insurance. Insurance in the following types and amounts is necessary:

- **Worker's Compensation Insurance** covering all liability of the Offeror arising under the Worker's Compensation Act and Worker's Occupational Disease Act. The amount of liability shall not be less than the statutory requirements for the State of Illinois.
- **Comprehensive General (Public) Liability** in a broad form, to include coverage for the following where exposure exists:
 - Premises/Operations, Independent Contractors,
 - Products/Completed Operations, Personal Injury and
 - Contractual Liability, limits of liability not less than:
 - \$1,000,000 each occurrence
 - \$2,000,000 general aggregate
- **Automobile Liability Insurance** shall be maintained to respond to claims for damages because of bodily injury, death of a person or property damage arising out of ownership, maintenance or use of a motor vehicle. This policy shall be written to cover any auto whether owned, leased, hired, or borrowed.

Each Occurrence Limit: \$ 1,000,000

* Contractor agrees that with respect to the above required insurance:

1. The CGL policy shall be endorsed for the general aggregate to apply on a "per Project" basis;
2. To provide separate endorsements: to name Lake County as additional insured as their interest may appear, and; to provide thirty (30) days' notice, in writing, of cancellation or material change
3. The Contractor's insurance shall be primary in the event of a claim.
4. Lake County shall be provided with Certificates of Insurance and endorsements evidencing the above required insurance, prior to commencement of this Contract and thereafter with certificates evidencing renewals or replacements of said policies of insurance at least thirty (30) days prior to the expiration of cancellation of any such policies. Said Notices and Certificates of Insurance shall be provided to: Lake County Purchasing, 18 North County Street, Waukegan, IL 60085-4350.
5. **Failure to Comply:** In the event the Contractor fails to obtain or maintain any insurance coverages required under this agreement, the Lake County may purchase such insurance coverages and charge the expense thereof to the Contractor.

Contractor agrees that with respect to the above required insurance, Lake County shall be named as additional insured, by endorsement, as their interest may appear; and be provided with thirty (30) days' notice, in writing by endorsement, of cancellation or material change;

Be provided with Certificates of Insurance and endorsements evidencing the above required insurance, prior to commencement of this Contract and thereafter with certificates evidencing renewals or replacements of said policies of insurance at least fifteen (15) days prior to the expiration of cancellation of any such policies. Said Notices and Certificates of Insurance shall be provided to:
