



- Pre-Bid Questions
 - Is there a budget for this project?
 - The budget for the project is included in the recommended projects referenced in the 2019 FY Capital Improvement Program:

- Can Protect-All Flooring, manufactured by Oscoda Plastics be considered as a substitute material for this project?
 - Refer to Specification Section 096519: Resilient Flooring, Part 2 Products for acceptable products. Refer to Specification Section 012500: Substitution Procedures.
- Will the County allow alternative SCADA software in this bid?
 - Refer to the Construction Drawings for specifications and requirements regarding automatic control systems for mechanical and electrical components.
- What wood veneer does the County want for the doors?
 - Wood veneer finishes shall match existing veneers in this area. Refer to Specification Section 081416: Flush Wood Doors, Part 2 – Products for information on veneer finishes.
- Can Hager door hardware products be considered a complete hardware set for this bid?
 - Refer to Specification Section 087100: Door Hardware, Part 2 Products for acceptable products. Refer to Specification Section 012500: Substitution Procedures.
- Clarifications:
 - Work in secure detention areas
 - Work outside of the envelope of the existing gymnasium that encroaches into secure detention areas will be subject to the measures necessary to comply with the requirements of the governing authority in these areas. Additional time should be factored for work in these areas, e.g. floor box punch throughs for electrical/data.
 - Work outside of the envelope of the existing gymnasium that encroaches into secure detention areas will be subject to the measures necessary to comply with the requirements of the governing authorities in these areas. Temporary measures must be accounted for to maintain the secure detention perimeter when performing demolition and new construction in these areas, e.g. temporary wall enclosures at masonry demolition locations.

 - o Drawing Nos. 1.AD102-PH5 and 1.AD202-PH5
 - Modifications have been made to these drawings to represent demolition work that is to be performed By Others. This work will be completed prior to the award of this contract.






